

Stallion Breeding Contract

1. A Booking fee of _____ to be paid upon execution of this agreement. This booking fee is not refundable. Mare care will be charged plus Veterinarian expenses. These expenses are to be paid by the mare owner when mare leaves the breeding ranch. The balance of the breed fee is to be paid when the mare leaves the farm. If the balance of the breeding fee is not paid in the specified time allowed then no live foal guarantee will apply with this contract and no breeding certificate will be issued, unless prior arrangements are made. If the mare does not settle, that mare may come back this year or if the owner wishes, the following year. The mare owner may substitute another approved mare. If the mare does not come back the following year, and no arrangements are made then no further money is owed on the breed fee and this contract is cancelled.
2. This contract carries a live foal guarantee to the extent of a return breed the following year. If the mare aborts or foal does not stand and suck, then mare owner is allowed a return breed, provided breed fee has been paid in full. If mare owner fails to return the following year, and no arrangement is made with stallion owner then this contract is cancelled, and no money that has been paid will be refunded.
3. The breeding ranch and the stallion owner agree to diligently try to settle each mare. If however, the mare does not settle the mare owner agrees to hold the breeding ranch and the stallion owner harmless.
4. The mare owner agrees to said mare being examined and treated, by the qualified veterinarian serving the stallion owner. Also the mare owner grants permission to the stallion owner to have veterinarian treat mare for anything that would insure her well being. Mare is to be current on vaccinations and worming.
5. Mare shall be halter broken and manageable. Mare shall be healthy and in sound breeding condition. It is understood and agreed by the mare owner that the breeding ranch and the stallion owner will not be responsible for accident, sickness or death of the mare and or her foal.
6. It is further agreed that should Watts Doc Breeze die, or become unfit to breed, then this contract shall become null and void.

7. A copy of the mare's registration papers shall be furnished to the stallion owner or the breeding ranch prior to or upon arrival of the mare.

8. PLEASE call the breeding ranch one day prior to arrival if possible phone (435)257-0624

9. This contract becomes binding upon the signature of the stallion owner and the mare owner

10. Failure to pay Breed fee will result in the Stallion owner becoming the sole owner of the foal.

11. All mares shall come to be bred with hind shoes removed.

12. Foal color guarantee applies to colt. Stallion owner guarantees that colt shall be grulla, buckskin or dun or mare can return next year for free rebreed. Again Mare care charges will be paid by mare owner.
